Dear Applicant:

The following Affidavit of Support form is required by Brooklyn-Queens Conservatory of Music and by the United States Department of Justice Immigration and Naturalization Service for all students desiring F-1 (Student) visa status. You must submit a completed Affidavit of Support form and supporting bank deposit statements; both must be originals, not photocopies. Please fill these out and return them to the Brooklyn-Queens Conservatory of Music as soon as possible so that we can process your application and send you your I-20 form quickly. In order to fill out the Affidavit of Support form it is necessary for you to know how much money you or your parent/sponsor will be able to provide for you. The estimated expenses for the upcoming academic year (two semesters/10 months) are as follows:

Tuition: \$8,400.00 (\$4,200.00 per semester, full-time)

Living Expenses: \$10,000.00 (food, rent, etc.)

Books & Music: \$600.00

Matriculation Fee's: \$500 (\$250.00 per semester)

Total: \$19,500.00

ALSO: \$3,000.00 per dependent who will accompany you.

You may indicate the total amount available in line #11. A signature on the Affidavit of Support means that you (or your sponsor) can pay the total expenses for an academic year (two semesters=10 months full-time). This equals 19,500.00 for you or \$22,500.00 for you and one dependent.

IMPORTANT: The Affidavit of Support form must be ORIGINAL (not fax/copy) and MUST be notarized by a Notary Public—usually an officer of your bank or a real estate broker or bondsman. The form IS NOT COMPLETE WITHOUT THE NOTARIZATION AND THE SPONSOR'S SIGNATURE.

Be sure to include an original bank deposit statement(s) showing that you or your sponsor has enough funds to cover the costs of your stay at the Conservatory for one year (\$19,500.00).

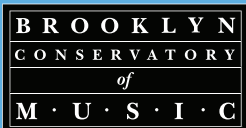

FINANCIAL DOCUMENTATION & AFFIDAVIT OF SUPPORT FORM

All foreign students admitted to the Brooklyn-Queens Conservatory of Music who expect to use the F-1 Student Visa must prove that they have financial support to cover at least the following expenses for the academic year (nine months):

Tuition: \$8,400.00 (\$4,200.00 per semester, full-time)
Living Expenses: \$10,000.00 (food, rent, etc.)
Books & Music: \$600.00
Matriculation Fee's: \$500 (\$250.00 per semester)
Total: \$19,500.00

If your spouse and/or children will accompany you in the U.S. you must provide evidence of additional financial support equal to \$3,000.00 per year per person.

A CERTIFICATE OF ELIGIBILITY (FORM I-20) CANNOT BE ISSUED UNTIL YOU COMPLETE AND RETURN THIS FORM WITH THE REQUIRED DOCUMENTATION. IF YOU ARE OVERSEAS, KEEP COPIES OF ALL DOCUMENTS—YOU WILL NEED TO PROVE YOUR FINANCIAL SUPPORT TO THE U.S. CONSUL IN YOUR COUNTRY IN ORDER TO GET YOUR ENTRY VISA.
